**Show Hours:** Advertised show hours are Saturday 10:00 a.m. to 5:00 p.m. and Sunday 9:00 AM to 5:00 p.m.

**Entry Info:** Entries are open now. Entries for Championship, Premiership, AOV, Provisional, and Miscellaneous classes must have the registration number on the entry blank and printed in the catalog. Kittens must be 4 months of age or older on opening day of the show. Household pets (HHP) 8 months of age or older must be spayed or neutered. All cats must be entered using the CFA online system, <https://entries.cfa.org/onlineEntry.php>. Entry Clerk may call collect to clarify entries. No fees are refunded for failure to bench. See Agility section below for agility entry info.

**Check-in:** Saturday, 1/24/2026 at 8:30 a.m. - 9:30 a.m. Judging begins promptly Saturday at 10:00 a.m. & Sunday at 9:00 a.m.

**New Exhibitors:** New exhibitors may identify themselves at check-in so that San Diego Cat Fanciers (SDCF) members can help make this a pleasurable first showing experience. **Show Hall:** Exhibit Hall, Del Mar Fairgrounds, 2260 Jimmy Durante Blvd, Del Mar, CA 92014. The show hall is not heated. Hall/facility are handicapped accessible. SDCF & Del Mar Fairgrounds are not responsible for damage, loss, personal injury, or loss of personal property. No cats may be left in the show hall overnight. **VENDING FROM CAGES OR GROOM SPACES IS PROHIBITED.** Small, discrete grand parties will be allowed. Food for purchase will be available outside of the Show Hall entrance.

**Directions to Show Hall:** From Interstate 5 take Exit 36 onto Via De La Valle. Proceed West toward Del Mar, Solana Beach. Drive past the Jimmy Durante intersection. In 0.4 miles turn left to the Solana Gate - this is a blind entrance with minimal signage and no traffic signal.

**Parking:** Solana Gate entrance offers a special vendor parking pass for both vendors and exhibitors. This special pass provides two (2) day parking for the price of one (1) day (\$20). Price is subject to change at the discretion of the Del Mar Fairground management.

**Airport:** San Diego International Airport (SAN) is the nearest airport. SAN is approximately 22 miles South of show hall.

**Benching:** Benching Cage Space (BCS) for an individual exhibitor is 45"L x 22"W. If an exhibitors show cage/shelter exceeds the BCS they must buy a Groom space. The club supplied wire cage is a 45" double cage with a partition (AKA two singles of 22"L x 22"W). Every two (2) cats from the same exhibitor will be presumed to share a 45" crate unless the exhibitor purchases a Groom. \*A single space is free for odd numbered cats with same owner. A 45" cage accommodates two (2) cats. A 36" cage accommodates one (1) cat or two (2) kittens. If an exhibitor brings their own show cage/shelter they must check the box located on the entry form to indicate that the exhibitor does not want a club supplied wire cage.

**Agility:** All agility entries must be benched. An agility cat may accompany a cat entered in the regular judging and thus be considered benched. Cats not entered in any other class, must be pre-entered so a benching space can be provided. Cats may be pre-entered using the CFA online system, <https://entries.cfa.org/agilityEntry.php>. Cats that are entered in any other class may be entered in agility on the day of the show - see the Agility Ringmaster located at the Agility Ring. A cat or kitten not having all its physical properties - eyes, ears, legs, tail, claws, both descended testicles **is eligible** for entry. Cats with wild ancestry **is not eligible**. Exhibitors bring toys/wands. Lasers are allowed in agility ring only. Food and treats are prohibited. Agility handlers must wear low-heeled shoes. **Health:** This is a non-vetted show. It is strongly advised that all cats or kittens entered or present in the show hall be inoculated before entry by a licensed veterinarian against feline panleukopenia (formerly known as feline distemper or feline infectious enteritis), feline rhinotracheitis, calici viruses and rabies. It is also strongly recommended that cats and kittens be tested and found negative for feline leukemia virus before entry. All cats must free of fungi and parasites. All cats should be bathed and all nails must be clipped prior to benching. Declawed cats are not eligible for entry.

**Litter:** Litter will be provided. SDCF does not supply litter trays, food, or bowls. Litter must be disposed of in designated outdoor receptacles. **DISPOSING OF LITTER INSIDE THE SHOW HALL IS PROHIBITED.**

**Awards:** Rosettes will be awarded in accordance with CFA Show Rules. Awards such as Best of Breed/Color awarded in the ring cannot be taken/kept by the exhibitor. All Championship, Premiership, and registered Kitten entries will be scored for CFA National and Regional points. SDCF reserves the right to add judges not previously identified to judge non-championship and HHP classes.
